Please read this document before signing. Signing this document affirms that you have read it and understand it in its entirety.

1. I the undersigned, as participant in the Sidesaddle Camp at the USET, in Gladstone, NJ, a facility of the USET Foundation: AGREE to hold harmless from any claim of liability, actions or petitions Paws and Rewind LLC dba Camp Leaping Horn, the USET, USET Foundation, camp organizers and instructors, their officers, agents, employees, servants, heirs, successors and assigns, that may result from injuries, incidents, accidents, property damage or other occurrences relating to my participation in this event.

2. The Equine Activity Liability laws of the State of New Jersey, § 5:15-3, state among its statutory provisions that “WARNING: UNDER NEW JERSEY LAW, AN EQUESTRIAN AREA OPERATOR IS NOT LIABLE FOR AN INJURY TO OR THE DEATH OF A PARTICIPANT IN EQUINE ANIMAL ACTIVITIES RESULTING FROM THE INHERENT RISKS OF EQUINE ANIMAL ACTIVITIES, PURSUANT TO P.L.1997, c.287 (C.5:15-1 et seq)

I, the undersigned, having read and understood the content of this document, agree and consent to the provisions contained herein. It is my intention and desire to participate in side saddle activities including but not limited to, riding, horse-handling, ground crew, lessons, showing or being present at equestrian activities as an observer or other activity related, however slight, to equestrian activities at side saddle events held at the USET. I hereby acknowledge that I am fully aware of the nature, purpose and risks of equine activities involved in sidesaddle camp. I acknowledge that these activities are potentially dangerous and that I voluntarily accept any of the inherent risks involved. In consideration for my being permitted to take part in these activities, I agree to obey the directions of camp officials. In the event of any disagreements or disputes arising from my taking part in these activities, I agree to release, hold harmless, and keep indemnified the sidesaddle camp and USET Foundation, their organizers and agents, officials, servants, and representatives from and against all claims, actions, costs, expenses and demands in respect to death, injury, loss or damage to my person or property, howsoever caused, arising out of or in connection with my taking part in these events even if the same may have been contributed to or occasioned by the negligence of the said body or any of its agents, servants, or representatives. It is understood and agreed that this agreement is to be binding upon myself, my heirs, executors and assigns under the laws of the State of New Jersey related to Equine Activity Liability I UNDERSTAND THAT THIS IS A LEGAL DOCUMENT. I HAVE READ AND UNDERSTOOD THIS RELEASE AND I UNDERSTAND ALL ITS TERMS. I EXECUTE IT VOLUNTARILY AND WITH FULL KNOWLEDGE OF ITS MEANING AND SIGNFICANCE. I HEREBY ASSUME ALL OF THE RISKS ASSOCIATED WITH EQUINE RELATED ACTIVITIES.
